These are briefly explained as follows:-

Part AI – Companies Act, 2017

1. On page AI-413, Seventh Schedule has been amended by **SRO 1476(I)/2018** dated December 06, 2018. This is re: **change in fee for Listed Companies Code of Corporate Governance.**

Part III – Rules & Regulations

2. On page AI-162(40), **SRO 1570(I)/2018** dated December 26, 2018 has been reproduced. This is re:- **Overseas Pakistani Foundation to maintain data bank.**
3. On pages AI-407 onwards, Public Offering (Regulated Securities Licensing) Regulations, 2017 have been amended by **SRO 1569(I)/2018** dated December 26, 2018.
4. On page AI-517, Regulation 16 of Intermediaries (Registration) Regulations, 2017 have been amended by **SRO 1521(I)/2018** dated December 14, 2018. This is re: **Conduct of intermediaries.**
